- 1. NOMINATION for JUDAN: Requires no less than 50% of the yudanshakais (7) represented on the Promotion Committee at the time on nomination. Each Yudanshakai joining in a judan nomination shall have its action pre-approved by its Yudanshakai board of directors prior to submission A motion to accept and second the proposal was made by Palacio and Kaneakua, respectively. The motion then passed on a voice vote.
- 2. MINIMUM TIME-IN-GRADE: Candidates for judan shall have held the USJF rank of kudan for no less than 10 years. There shall be no judan promotion awarded for any candidate not holding USJF kudan rank. A motion to accept and second the proposal was made by Palacio and Kaneakua, respectively.
